

Battery Jumpstart Assistance

If you have purchased a MotoMaster, MotoMaster OEPlus or MotoMaster Eliminator AGM automotive battery, you're automatically enrolled – there is no need to register or activate. All you need is your battery purchase receipt. Keep it in your vehicle so it's handy should you need it.



Need a boost?

1. For 24-hour service in Canada or the United States, call 1-800-444-4597.
2. Provide the battery model number and date of purchase (both shown on your purchase receipt) and we'll dispatch a service provider.
3. When the service vehicle arrives, show them your battery purchase receipt.

The Power Assist Program is limited to 3 jumpstart incidents over the coverage term – 3 years on MotoMaster series, 4 years on MotoMaster OEPlus series and 5 years on MotoMaster Eliminator AGM series batteries, from date of battery purchase.

Jumpstart assistance is strictly limited to the jumpstart of a defective battery. If towing or other services or repairs are necessary, we can dispatch a tow truck and tow your vehicle to the nearest Canadian Tire Service Centre. **Note:** the customer will be responsible for the payment of these services and repairs.

Repeated service calls for a battery which has been run down due to owner failure to turn off lights or other excessive electrical use will not be covered. No service will be provided in any instance when the battery will not start as a result of collision, vandalism, accident, or similar causes. Service will be provided only for 4-wheeled, on-road, motorized passenger vehicles, vans and light trucks that may be serviced with standard equipment and does not apply for batteries used in commercial applications.

The Power Assist Program is not transferable and is automatically cancelled in the event that the vehicle for which the battery was originally purchased is sold, leased or otherwise disposed of unless prescribed by law.

Power Assist Program is subject to change without notice.

Keep your purchase receipt safe.
It is required for warranty.

Battery Limited Warranty

Original proof of purchase required for warranty claim.

MotoMaster Canada warrants to the original retail customer that if any new battery purchased from Canadian Tire fails within the warranty period and our testing proves that it will not accept or hold a charge due to defects in material or workmanship, the battery will be replaced free of charge with a battery of equal quality and size in exchange for the defective battery. The replacement battery provided under the warranty will be covered by the unexpired balance of the initial warranty term.

The warranty period for your specific battery can be found on the battery itself.

The limited warranty does **not** apply if:

- The original proof of purchase is not presented at the time of the warranty claim, or
- Battery serial number, identification and/or date code markings have been altered or removed, or
- Battery is used in an application for which it was not intended, or
- Battery container, cover or terminals are broken, or
- Battery had been opened (non-serviceable batteries only), or
- Battery has been damaged due to abuse or neglect, including but not limited to fire, wreckage, collision, explosion, freezing, overcharging, undercharging, sulphation, or addition of any chemical or solution other than water

From time to time, our battery warranty terms may change. However, provided the customer has his/her original proof of purchase, the warranty in effect at the time of the original purchase is to be used in making the adjustment.

The replacement of the battery specified herein including provision of the Power Assist Program services shall be the sole and exclusive remedy to which MotoMaster Canada, Canadian Tire Financial Services or the retailer are obligated and to which the original retail customer is entitled. Notwithstanding the generality



of the foregoing, the retailer shall not be liable for reimbursement of the original purchase price, cost of installation, loss of the use of the vehicle, loss of time, inconvenience, towing charges, rental of a replacement vehicle and any other special, incidental, consequential or punitive damages.

This limited warranty and the Power Assist Program are in lieu of any other warranties expressed or implied including the implied warranties of merchantability and fitness for a particular purpose.

Some provinces do not allow the exclusion of limitation of incidental or consequential damages or limitations on transferability so the above limitations may not apply to you. This warranty gives you specific legal rights and you may also have other rights that may vary from province to province.

This warranty is not transferable and is automatically cancelled in the event that the vehicle in which the MotoMaster battery has been installed is sold, leased or otherwise disposed of unless prescribed by law.
